V33 BOAT VARNISH



Waterproof – Anti abrasion Clear gloss

Destination

Suitable for all types of wood, European and exotic.

Recommended for external woodwork subject to difficult exposure: boat bridges, gateways, seaside house doors and windows, terraces, balconies...

Characteristics

This Marine Varnish, based on polyurethane resins and anti-UV gives optimal protection to your outdoor window and door frames, subject to marine climates and heavy exposure to the sun.

Its formulation makes it absolutely watertight and resistant to sea salts.

Its strong abrasion-resistance means it can be applied in outdoor passageways: terraces, balconies, outdoor stairways...

Surface preparation

NEW WOOD: Brush and remove dust. Dilute the 1st coat with 10% White Spirit. VARNISHED WOOD: Carefully sand using fine grit paper (240). If the varnish has scaled, strip it using V33 Special Wood Stripper. Rinse with water or V33 Cleaning Solvent. Leave to dry for 24 H.

Application

Stir well before use.

Apply with a flat brush or spray gun (dilute with 10% White spirit) in two coats on clean, dry and completely degreased wood.

Leave the 1st coat to dry for 6 hours.

Sand lightly with fine glass paper (240) and dust before applying the second coat.

Tips for application

Ideal conditions for application: 12 to 15°C in dry weather.

You are recommended to degrease oily wood before applying the varnish, using V33 Cleaning Solvent.

You are recommended to slightly round the corners of your woodwork with glass paper, to ensure an even coating of varnish.
